#### DATA PROTECTION IN THE COMPANY OR GROUP IS TEAMWORK!

Personal data is handled in the decentralized departments or business areas. It is there that the organizational and legal requirements of data privacy must be implemented responsibly and effectively. Data Protection Coordinators have proven to be an important interface to the data protection specialists in the data protection organization, Data Protection Management and the Data Protection Officer.

In this function, they provide solution-oriented support to their colleagues in the departments or business areas in identifying and classifying data protection-relevant processes. In this way, standard issues relating to the handling of personal data can be clarified independently with the departments or business areas for ensuring compliance, or the support from data protection specialists in the company can be coordinated in a targeted manner. In addition, practical experience shows that the departments need support in dealing with organizational data protection tasks such as documentation, data breaches, and inquiries from data subjects.

Therefore, the job of Data Protection Coordinators requires an understanding of the principles of data protection law and organizational data protection requirements.

#### **OBJECTIVE**

Your task as a Data Protection Coordinator requires an understanding of the basic principles of data protection law being stipulated by the General Data Protection Regulation (GDPR) and the organizational data protection requirements. In order to be able to correctly classify data protection-relevant issues, you will therefore first receive an introduction to the main features of data protection law.

Another focus is to explain the roles, tasks and background of the most important data protection processes for companies in a practical manner. The focus is on the operational tasks of the departments or business areas and the support options as a Data Protection Coordinator.

This will give you the fundamental knowledge you need to fulfill your role as Data Protection Coordinator in the interface between the departments and business units as far as to the Data Protection Organization, Data Protection Management or the Data Protection Officer.
